Security will advise the Water Company personnel as to the place and nature of the Fire Call Out.

The reason for the Water Company personnel to be contacted is to monitor the water storage and the system.

The Hydrants used by the Fire Company are not FIRE Hydrants and are use by the Water Company for their MAINTENANCE OF THEIR LINES. However, the Water Company has agreed to allow the Fire Company to utilize these hydrants as a water source, but in doing this they make no commitment to their use as FIRE HYDRANTS, AS THEY ARE NOT FIRE HYDRANTS.

The Water Company will assist the Fire Company in determining where and which hydrants to use in fighting the fire. This procedure should aid the Fire Fighters in establishing a proper water source in close range to the fire. Also, will ensure an adequate and proper supply is available.

Should this program fail and the Water Company Personnel are not available in a timely fashion. The Fire Company can start to pull water from the Lake or the Pond (on Bear Run) until a working fire hydrant in close range to the fire is established.

A list of Non-Functioning Fire Hydrants shall be maintained at the Security Guard Building.
