## **Rules & Regulations**

## 003 D: Sports Complex

The Beech Mountain Lakes Sports Complex is made up of the Clubhouse (including the Racquetball Courts, Game Room, Swimming Pool, and Workout Center) and the immediate surrounding area – beach, boat docks, tennis court, bocce court, playground, basketball court and volleyball area. The Sports Complex is for the exclusive use of BML members in good standing, registered guests of Quail Hollow Village and visitors of either.

To insure safe and enjoyable use of the Sports Complex, the following rules apply (in this document, "Member" is used to refer to a BML resident, a QHV registered guests or their visitors):

#### **General Rules**

- Children under the age of 11 must be accompanied by a parent or supervising adult at all times.
- Children under 14 years of age must be accompanied by a parent or supervising adult when in the Clubhouse or when using the pool or beach area.
- Members or supervising adults will be responsible for the behavior and conduct of guests and/or children for whom they are designated as the responsible person.
- Members or supervising adults will be liable for damage to BML property caused by them, their visitors or children for whom they are designated as the responsible person.
- Everyone using the pool, fitness room, courts or game room must present a current membership card to gain access.

#### **Member Responsibilities**

It is each Member's responsibility to register each visitor. All visitors, accompanied by a member in good standing, must apply for a guest pass at the Recreation Office. There is no charge for the first 6 visitors per member household per visit; after the sixth visitor, a \$3.00 fee per person will be charged.

#### Whirlpool

Children under the age of 18 are not allowed in the whirlpool.

#### **Workout Center**

Children ages 14 through 17 are not allowed to use the Workout Center unless they are accompanied by someone 18 years of age or older.

### Swimming pool

- Children who are not toilet-trained must wear elasticized plastic pants over their "swimmies". The pants are available in the recreation office.
- Throwing hard objects (including hard balls) is not permitted in the pool or pool area.
- No toys may be purposely pulled apart in the pool area, including those made of foam, sponge, or other plastics.
- Shoes worn out-of-doors are not allowed in the pool area.
- No food or drink is allowed in the pool or pool area.

# Clubhouse

Wet bathing suits are allowed to be worn in the clubhouse outside of the pool area **only** when one is going to use the bathroom facilities. Shoes are to be worn at all times in the clubhouse with the exception of the pool area deck.

## Court use

Use of the Racquetball and tennis courts must be scheduled by the recreation office on a one hour time period basis. Please check for availability of court time. Reservations will be accepted up to one week in advance (570-788-1199). Appropriate court shoes are required at all times. Please do not wear black soled shoes on either court.

#### **Picnics**

Picnics are permitted only in designated areas.

# Behavior at the Sports Complex

Disorderly conduct such as (fighting, pushing, slapping, obscene language, unreasonable noise, etc.) will not be tolerated. After each verbal warning an incident report will be filed by the recreation attendant. After two verbal warnings and/or incident reports within one-month period, members may have their clubhouse privileges suspended.

Alcoholic beverages purchased by the drink in the bar/restaurant area must be consumed where purchased. No opened alcoholic beverage (in a glass of any kind, bottle or can) may be taken out of the bar/restaurant area.

Skateboarding, bicycling, roller skating and in-line skating will not be permitted on decks or other areas designated by the recreation staff or board of directors.

Violations of this section are considered dangerous to pedestrians. After two verbal warnings and/or incident reports within one-month period, members may have their clubhouse privileges suspended.

The recreation attendant and/or staff has the right and responsibility to enforce all rules and regulations, and for keeping all entrances and exits free from blockage, whether intentional or unintentional. Persons asked to disburse and/or refrain from gathering around entrances and exits will be expected to do so immediately.

No solicitation will be permitted on the clubhouse property without prior consent of the General Manager or the board of directors.

Fishing is not permitted on or in the area of the private docks or where prohibited by signs.



# BEECH MOUNTAIN LAKES CLUBHOUSE FACILITY RULES

- 1. IT IS EACH MEMBERS RESPONSIBILITY TO REGISTER EACH GUEST. ALL GUESTS MUST BE ACCOMPANIED BY A MEMBER IN GOOD STANDING WITH A CURRENT MEMBERSHIP CARD TO APPLY FOR A GUEST PASS. THIS PASS WILL LIST MEMBER NAME / GUEST NAME / NUMBER OF DAYS STAMPED BY THE RECREATION ATTENDANT. (MAXIMUM 6 GUESTS PER HOUSEHOLD PER VISIT TO BE RENEWED WEEKLY.)
- 2. CHILDREN UNDER 16 ARE NOT ALLOWED IN THE WHIRLPOOLS OR SAUNAS. CHILDREN, AGES 14 THROUGH 17 SHALL NOT BE ALLOWED TO USE THE WEIGHT/FITNESS ROOM UNLESS ACCOMPANIED BY ANOTHER INDIVIDUAL TO BE USED AS A SPOTTER.
- 3. SWIMMING POOL: AFTER THE  $6^{\text{TH}}$  PERSON IN A GROUP, A \$3.00 FEE WILL BE CHARGED PER PERSON.
  - A. DIAPERED BABIES ARE NOT PERMITTED IN THE POOLS.
  - B. THROWING HARD OBJECTS SUCH AS BALLS ARE NOT PERMITTED IN POOL AND POOL AREAS.
  - C. NO TOYS WILL BE PERMITTED TO BE PURPOSELY PULLED APART IN THE POOL AREAS. (THIS INCLUDES FOAM, SPONGE AND THE LIKE DUE TO POSSIBLE DAMAGE TO THE FILTERS.
  - D. NO FOOD OR DRINK WILL BE ALLOWED IN POOL OR POOL AREAS.
- 4. DO NOT WEAR WET BATHING SUITS, OUTSIDE OF THE POOL AREA, EXCEPT FOR USING BATHROOM FACILITIES. SHOES ARE TO BE WORN AT ALL TIMES WITH THE EXCEPTION OF THE POOL AREA DECK.
- 5. RACQUETBALL AND TENNIS COURTS MUST BE SCHEDULED BY THE ACTIVITIES DESK ON A ONE HOUR TIME PERIOD BASIS. APPROPRIATE COURT SHOES ARE REQUIRED AT ALL TIMES. PLEASE CHECK FOR AVAILABILITY OF COURT TIME. RESERVATIONS WILL BE ACCEPTED UP TO ONE FULL WEEK IN ADVANCE. PHONE 1-800-498-7676. PLEASE DO NOT WEAR BLACK SOLED SHOES ON EITHER TYPE OF PLAYING COURT.
- 6. PICNICS ARE PERMITTED ONLY IN DESIGNATED AREAS.
- 7. CHILDREN UNDER 14 YEARS OF AGE MUST BE, AT ALL TIMES, ACCOMPAINED BY A SUPERVISING ADULT WHEN USING THE BEACH OR POOL AREAS. MEMBERS OR SUPERVISING ADULTS WILL BE LIABLE FOR DESTRUCTION OF POA PROPERTY. MEMBERS OR SUPERVISING ADULTS WILL BE RESPONSIBLE FOR THE BEHAVIOR AND CONDUCT OF GUESTS AND/OR CHILDREN FOR WHOM

THEY ARE DESIGNATED AS THE RESPONSIBLE PERSON (CHILDREN UNDER 14 YEARS OF AGE ARE NOT PERMITTED IN THE RECREATION COMPLEX UNLESS A

PARENT OR SUPERVISING ADULT IS ALSO PRESENT ON THE PREMISES.)

(CHILDREN 10 YEARS OF AGE AND YOUNGER MUST BE UNDER THE DIRECTION AND CONTROL OF THEIR PARENT OR A SUPERVISING ADULT AT ALL TIMES.)

- 8. DISORDERLY CONDUCT SUCH AS FIGHTING, PUSHING, SLAPPING, UNRULINESS, OBSCENE LANGUAGE, UNREASONABLE NOISE AND ETC. WILL ABSOLUTELY NOT BE TOLERATED. AFTER EACH VERBAL WARNING, AN INCIDENT REPORT WILL BE FILED BY THE ATTENDING RECREATION STAFF MEMBER ISSUING SUCH WARNING.
  - AFTER TWO SUCH WARNINGS AND/OR INCIDENT REPORTS, OFFENDING MEMBERS MAY HAVE THEIR RECREATION PRIVILEGES SUSPENDED.
- 9. EVERYONE USING THE POOL, WHIRPOOL OR FITNESS AREAS MUST PRESENT A CURRENT MEMBERSHIP CARD, AND SIGN A WAIVER OF LIABILITY AT THE ACTIVITY DESK BEFORE USING THE FACILITIES.
- 10. ALCOHOL BEVERAGES PURCHASED IN THE BAR/RESTAURANT MUST BE CONSUMED IN THE LICENSED AREAS OF THE BAR/RESTAURANT. SIX PACKS (BEER) WILL BE PERMITTED TO BE PURCHASED FOR TAKE-OUT PURPOSES.
- 11. SKATEBOARDS ARE NOT ALLOWED ON CLUBHOUSE PROPERTY. SKATE BOARDING, BICYCLING, ROLLER-SKATING AND IN-LINE SKATING WILL NOT BE PERMITTED ON DECKS, SIDEWALKS, OR OTHER AREAS DESIGNATED BY THE RECREATION STAFF OR BOARD OF DIRECTORS. VIOLATIONS OF THIS SECTION ARE CONSIDERED DANGEROUS TO PEDESTRIANS AND WILL BE SUBJECT TO THE SUSPENSION OF PRIVILEGE LANGUAGE ABOVE.
- 12. THE RECREATION ATTENDANT AND/OR STAFF WILL HAVE THE RIGHT TO ENFORCE ALL RULES AND REGULATIONS AND SHALL BE RESPONSIBLE FOR KEEPING ALL ENTRANCES AND EXITS FREE FROM GATHERINGS AND INTENTIONAL OR UNINTENTIONAL BLOCKAGE. ALL PERSONS ASKED TO DISBURSE AND CEASE FROM GATHERING AROUND ENTRANCES AND EXITS WILL BE EXPECTED TO DO SO IMMEDIATELY.
- 13. CHILDREN UNDER THE AGE OF 10 ARE WELCOME TO ATTEND ANY ORGANIZED STAFF ACTIVITY OR OTHER SUPERVISED ACTIVITY, WITH WRITTEN PARENTAL CONSENT.
- 14. NO SOLICITATION WILL BE PERMITTED ON THE CLUBHOUSE PROPERTY WITHOUT PRIOR CONSENT.
